## NOTICE FOR THE PENSIONERS

This is for information of all the Pensioners of the University that the revision of Pensions of all has been revised as per Govt. Orders, issued in this respect, w.e.f. 01.01.2020 in June 2020. We had also disbursed the arrears from 01.01.2020to all. Any Person / Pensioners having query on the revision are requested to send mails to <a href="mailto:fo@jadavpuruniversity.in">fo@jadavpuruniversity.in</a> visit RB Cell during 5-9th October 2020.

The relevant Govt. orders are as follows:

1. GPF Scheme: 302-Edn.(U) dated 13.3.2020;

2. CPF Scheme: 363-Edn.(U) dated 12.6.2020.

The pensioners, those retired after 01.01.2016, are entitled to get arrears in respect of Gratuity and Pension commutation, with option (on the additional part of the revised Pension), for which the calculations are going on. To get the benefits of the additional commutation, a Pensioner is required to submit option as per G.O., specified in the annexure, copies enclosed. It is observed that the actual takehome will be reduced by 19% in case of CPF Pensioners & 29% in case of the GPF Pensioners. Thus, the question of options need to apply to have consent. Those will not submit such option for commutations, will not be favoured with the additional commutation.

It is requested to all concerned to submit option preferably by 9<sup>th</sup> October, so that we can finalise the disbursement process within immediate next week [12-16 Oct]. Thus, the attention of all concerned is required to help us to disburse the amount. The additional Gratuity as arrears will be paid shortly, to all eligible cases.

All pensioners are requested to submit their Income tax savings plan to the Undersigned in mail within 9th October 2020, so that we can apply it for TDS-IT calculation purpose.

Cooperation of all concerned is solicited.
